MEMBER AGREEMENT

The undersigned member of **GLADES ELECTRIC COOPERATIVE, INC. (GEC)** hereby agrees to lease the Home Guard (EFI) Meter Base Device and Starter Kit (EQUIPMENT) from GEC for a period of two (2) years from the date hereof. At the end of the said two (2) year period this agreement will continue on a month to month basis until terminated by either party by giving thirty (30) days written notice. The undersigned member agrees to pay GEC an installation fee plus six (\$6.00) dollars per month for the Equipment and understands that the lease payment will be shown as a separate item and be payable with the member's electric bill. If the member terminates this lease before the end of the said two (2) year period, the member agrees to pay a One Hundred Fifty (\$150) Dollars termination fee.

The Member hereby grants to GEC the right to install, operate, maintain, and rights of ingress and egress to and from the Equipment. Neither Member nor any person acting on the Member's behalf shall install, repair, remove, service, or otherwise TAMPER with the meter base Equipment. In the event of any problem with or failure of the Equipment, or to file a claim, the Member shall notify EFI (manufacturer of equipment) by calling the toll free number listed on the warranty sheet (800-877-1174 ext. 407) to obtain a claim package (see Warranty Information). Damaged appliance(s) and related equipment must remain available for inspection until the claim is finalized.

Recovery under this Agreement is limited to the Member. GEC liability for covered damage shall be limited to the consequential damage coverage provided by the equipment manufacturer (PSG Enterprises as the administrator and EFI Electronics Corporation as the manufacturer), set forth in the consumer warranty.

THE EQUIPMENT GUARANTEES FOR THE MEMBER NAMED HEREIN ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE; AND ALL SUCH OTHER WARRANTIES ARE HEREBY EXPRESSLY DISCLAIMED.

IT IS UNDERSTOOD AND AGREED that the Equipment is leased to the Member and shall remain at all times the property of GEC.
